Dear Ms Evans,

Will we tell future generations that we stayed silent over harmful radiation?

I recently spoke with a highly respected local councillor who informed me that they were fully aware that the radiation from 5G masts extends far further than that of 3G and 4G, and is known to cause cancer. 5G is not necessary for faster communication, as 4G is more than adequate. Other councillors and scientists are also concerned with the dangers of 5G.\*

- Government guidance informs us that telecom masts should not be refused on health grounds in circumstances where ICNIRP guidelines are met. *However, ICNIRP guidelines refer to thermal effects (heat) from EMF radiation but not to non-thermal effects.\**
- The World Health Organization classifies non-ionizing radiofrequency radiation (RFR) as a possible human carcinogen. <https://tinyurl.com/WHOpossible-cancer> \*
- ICNIRP guidelines do not consider EMF radiation health harms for people with any metal implants including metal dentistry or pacemakers, which includes most of the population.\*
- The US-based telecoms company Verizon, with offices in the UK, make provision in their statutory accounts for potential EMF health claims.
- In a patent application from Swisscom, the industry declared this technology to be carcinogenic through non-thermal pathways.
- Insurance underwriters, it appears, do not provide cover for the effects of EMF radiation from telecom masts.
- The National Planning Policy Framework (NPPF), which contains reference to the above ICNIRP guidance, is not statute, as noted by the UK Supreme Court.
- Following NPPF does not exempt Councils from liability in instances of harm caused by non-ionizing RFR.

- London's Wandsworth Borough Council stated in an FOIA reply that their insurer does not cover them for EMF radiation effects.
- Each 5G mast requires approximately 3 x more power than a 4G mast (as much as 73 typical homes) so the technology is clearly not 'green'. \*

There are more scientific health effects to divulge, which for brevity won't be discussed herein.

Many ICNIRP certificates have been issued to councils in the name of "Three UK Limited" a company dissolved in October 2015. Could this be an attempt to avoid liability?\*

It is no longer conscionable to stay silent and do nothing. Globally, we have been misled by governments about the reasons for installing unnecessary and harmful 5G technology, which is associated with multiple harmful health effects, including cancer. Furthermore, this technology is dangerous to anyone with metal implants, and is uninsurable for harms, and should be removed.
